August 22 – CHANGE FEE GOES INTO EFFECT: \$15 change fee will be assessed for changes made to a contract after this date.

August 29 – DEADLINE FOR CONTRACT PRICING: After August 29, any new contracts or additions to contracts will be at walk-on rates.

August 29 – DEADLINE FOR LEVEL DESIGNATIONS TO BE MAINTAINED. Any session without 10 contracted skaters as of Aug. 29, 2010, will be designated OPEN.

Make up vouchers will be given for each missed contracted session. Vouchers will be good for 30 days from issue date.

Short term absences, illnesses or injuries for which a skater misses less than two weeks (with or without a doctor's note) are not refundable. Make up vouchers will be issued.

PSC maintains it's policy not to prorate sessions.
