Contracting and Skating:

For contract pricing, all applications and payments are due by January 13th. After January 13th, contracts will be accepted, but walk-on rates apply. **Priority for contracts and ice sessions:** 1) Home Club 2) Associate Members. 3) Nonmembers 4) "half-session" walk-ons (Up to capacity)

▶ Home Club Membership or Associate Membership required to contract, guest walk-on ice generally available.

- ▶ Contract discounts for exceeding 36 hours of ice time, approximately 4 hours per week during winter session.
- ▶ Current USFS membership, PSC liability waiver, Ohio Lindsay's Law, and concussion forms required to skate on all sessions.
- ▶ Deposits due with each contract, check, Visa and Master Card accepted.
- ▶ If less than 12 skaters are contracted for a session; PSC reserves the right to cancel, change levels or disciplines.
- ▶ 1-Hour minimum purchase. Additional time may be purchased as 30-minute or 1-hour walk-on up to rink capacity.
- ▶ Skaters not skating the entire 1-hour session (half-session walk-ons) receive lowest priority, and may be denied if rink is at capacity.
- ▶ Discount coupons are sold to members and associate members as books of 5 one-hour increments.
- ▶ Please note price increases, \$2/hour "across-the-board" increase (Contracts, Coupons, Walk-ons). "City Free" will be increasing by \$2 (walk-on and punches) pending approval by Cleveland Heights City Council. Effective date TBA.

Note from PSC President: We have maintained our price for many years (no board members can remember the last increase). This increase is consistent with the planned increase in our per-hour ice costs and the pending \$2 increase in "City-Free" rate. Please note that we will be phasing out old (pink) coupons. The old coupons will be honored at their face value, which were purchased at a \$2 discount (\$15 value for \$13). Skaters will need to remember to provide an additional \$2/coupon until their pink coupons are exhausted. We apologize for this inconvenience. In addition, when approved by City Council, the "city free" punches will be sold as "10 punches for \$110" which also reflects this \$2 increase. There will also be an increase in minimum purchase (from increments of 7 punches to increments of 10 punches). - ▶ Walk-on rates: 1-hour: \$17, 90-minutes: \$26, 2-hours: \$34. Cash, check, Visa and MasterCard accepted.
- ▶ Guest skaters welcome, requires USFS membership, session level eligibility, and completion of PSC waiver forms.
- ▶ Guest coaches please contact the club in advance of visit, guest coaching form required.
- ▶ A \$25.00 fee will be charged for returned checks.

PLEASE NOTE:

- ▶ **Contracting Requirements:** Must be a current home club or associate member to contract. Priority Order: Contracted, Home Club, Associate Member, guest walk-on, up to rink capacity
- ▶ **Signing In:** All skaters must sign in with the monitor at the beginning of the session. Payment for session required prior to skating for all walk-ons.
- ▶ **Discounts:** 7.5% discount for 1 hrs ice sessions will be applicable to all contracts which equal or exceed 36 full, 1 hour ice sessions (average of 4 hours or more per week)
- ▶ **Contract Pricing Deadline:** Winter contract pricing effective until January 13, 2020. Regular walk-on rates apply to all sessions after Jan. 14, \$17 per hour.
- ▶ **Payments:** Contracts may be paid in full on January 13, 2020 or be made in 2 installments. 1st 50% payment due January 13, 2020. 2nd (Final) 50% Payment due February 18, 2020.
- ▶ **Late Arrival:** Contracted skaters arriving more than 10 minutes late lose priority. Skater must leave ice at end of session.
- ▶ **Refunds:** PSC maintains its policy not to prorate sessions. There will be no retroactive refunds.
- ▶ **Make-up sessions:** Contracted skaters may switch up to a total of 16 sessions. Make-up sessions valid only for length of the contract; void after March 16, 2020. Makeups may only be transferred to family or partner.
- ▶ **Same Day Session Switch:** Same day session switches available, with loss of priority. Does not count as a make-up session.
- ▶ **Open FS/High Club -** All sessions: require minimum Pre-Preliminary Moves test, or with coach, or prior authorization by PSC Pro-Chair or President. High Club: requires passing a Freeskate or Dance test.
- ▶ **Session Change:** If less than 12 skaters are contracted for a session, PSC reserves the right to cancel sessions, change levels or disciplines as needed.
- ▶ **Session Cancellation:** Occasionally circumstances require the cancellation of a session, a make-up session will generally be issued in such circumstances.
- ▶ **Liability Waiver:** Skating on all PSC Club sessions requires Liability Waiver Form, completed within last 12 months, renewed before July 1 of each year.
- ▶ **Contacting PSC:** Email (pscoffice@pavilionfsc.com) is PSC's typical form of communication. Please refer to our eblasts for rink and ice updates. If you are not receiving our eblasts, please contact the club office.
